1. OPTION 1 – FULL-TIME:
ne "Artist" commits to "Gallery" participation in accordance with participation terms listed below:

• Full-Time Gallery fees in the total amount of \$600.00 paid in 12 monthly installments of \$50.00 per month or a lump sum payment of \$600.00.
• Monthly installments are due by 12:00 PM on the first Monday of each month.

- **2. Artist Responsibilities:** In addition to the payment of receiving fees as stated above, the Artist is responsible for the following gallery requirements.
  - Artist must work **1 (one)** gallery shift(s) per month.
  - Gallery work shifts must be scheduled prior to noon on the date of Receiving.
  - Adherence to Gallery Receiving Procedures
  - Adherence to Gallery Prospectus.
  - Participation in a ACSWF or Gallery committee once every two years.
- **3. Termination:** Failure to fulfill the Artists Responsibilities may terminate this Agreement with **5** days' written notice.
- 4. Miscellaneous:
- 4.1. This Agreement constitutes the entire understanding between the parties.
- 4.2 As of January 1, 2025, receiving fees may be paid via cash, check or credit card.
- 4.3. Any amendments to this Agreement must be made in writing and signed by both parties.
